Sub: Request of the school for Composite Provisional Affiliation up to Senior Secondary Level (Under Switch over Category) - regarding.

With reference to your online application dated. SS-00613-1718 dated 17.06.2016 on the subject cited above; I am directed to convey the sanction for **Composite Provisional Affiliation for Secondary School Examination and Senior Secondary School Certificate Examination** of the Board for a period of **three years i.e. 01.04.2017 to 31.03.2020**. The following subjects have been sanctioned to be introduced at Senior Secondary classes:-

- Languages:** - English Core, English Elective, Hindi Core, Hindi Elective.
- Elective Subjects:** Physics, Chemistry, Biology, Computer Science, Mathematics, Informatics Practices, Accountancy, Business Studies, Economics, History, Political Science, and Physical Education

The above sanction is subject to fulfillment of following conditions:-

- The affiliation Code Number allotted to your school is **531457**. This may please be noted and quoted for any further correspondence with the Board.
- The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.
- The school must follow **Uniform System of Assessment, Examination and Report Card for classes VI-IX from Academic Year 2017-18 onwards as per the Board's Circular No.: Acad-14/2017, dated 21.03.2017.**
- The school must submit its information through Online Affiliated School Information System (OASIS) as per the Board's Circular No:CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website : [www.cbse.nic.in](http://www.cbse.nic.in)
- It is the case of switch over from State Board; the school is required to **withdraw its affiliation from State Board as dual affiliation is not permissible.** Also State Board classes IX and XI will not be continued w.e.f. **01.04.2017**. However, for the Class X and XII Examination to be held in the year **2019**, the school will sponsor its students for State Board only.
- The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
- It will increase the number of equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
- The school will follow the **RTE Act, 2009** and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time.
- The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre Primary to Class XII :-

	Campus area	Enrolment	No. of Sections (pre-primary to X)
(a)	1.0 acre	1250	02 in each class
(b)	1.5 acre	1875	03 in each class
(c)	2.0 acre	2500	04 in each class

- School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.
- Schools running on less than 01 acre campus in metropolitan cities shall restrict number of students as follows:-

	Category	Area of land	No. of students
(i)	Secondary School	2000 sq. mtrs	600 upto Class X
(ii)	Sr. Secondary School with two streams	3000 sq. mtrs	900 upto Class XII

- School should have at least one adequately equipped computer lab with a minimum of 10 computers and would ensure **computer student ratio of 1:20** at least. Proper software along with facility of Broad Band connectivity with the feature of 'internet always on' from any service provider to be ensured
